Flu Vaccine Shortages

Over the course of the last month various headlines in the news have called our attention to a lack of available flu vaccines for the coming winter. What happened? An American company operating in the UK called Chiron, identified that its flu vaccines were manufactured incorrectly and were contaminated with a bacteria called serratia. The United Kingdom publicly announced that it would not be purchasing vaccines from Chiron, and the US followed suit.

As a result of this, the US is now experiencing a sharp decrease in the number of available flu shots, yet the UK is not. Why is this? "public health experts have long cautioned against the country's dependence on a few vaccine makers, and yet this has become standard practice. There are now only two major manufacturers for the nation's supply of flu vaccine, and at least a half-dozen other vaccines are made by single suppliers. Britain, by contrast, has spread its order for flu vaccines among five suppliers, precisely to avoid the kind of predicament America now faces." (With Few Suppliers of Flu Shots, Shortage Was Long in Making. Denise Grady, NY Times 10/16/04). As a result of this you can urge your legislators to push for

purchasing vaccines from multiple companies to avoid this kind of situation again; and also to advocate for more incentives for vaccine manufacturers to remain in the market given unprofitability. Grady goes on to explain that this problem is mitigated by the fact that there is no real supervision regarding the distribution of vaccines, the process is handled by the pharmaceutical companies themselves. Problems occur when not enough companies stay in the market, the government relies on too few companies to provide vaccines. Currently, the US is relying on the products from 2 companies, Aventis Pasteur, and Medimmune both of which will provide for about half the needed doses.

Grady also goes on to explain how the Bush Administration has increased its budget for increasing research for flu vaccines to \$283 million, but questions remain, do we need to spend an extra \$236 million on vaccine research? Or do we need spend our money on ensuring a greater availability of doses from multiple sources?

The AMA and Prescription Drugs

During late October the American Medical Association has begun to call for negotiation of drug prices by the government. This is in response to the clause in the Medicare Modernization and Improvement Act of 2003 that prevents the government from negotiating prescription drug discounts. The policy implication of this restriction disallows any kind of saving with respect to prescription drugs by the government. Let your voice be heard, urge your legislators to spend your tax money wisely!

Caring for the Underserved: Careers in Community Health
